Holding this information online provides information to parents and allows them to be more involved in their child's early education. Information can be filtered and displayed in different ways, and assessments and statements can be made for each entry.

# CPOMS

CPOMS is a safeguarding software used within each Federation school to record any incidents regarding behaviour, pastoral concerns or issues to the safeguarding of children. Staff record incidents on the system and these can be read by the appropriate member of staff. Letters/reports are also scanned onto the system, so the Federation school has a full record of information relating to a pupil. Holding this data electronically improves efficiency and appropriate sharing of information.

Only the DSL's, DDSL's and SLT can view child protection records, unless we invite an appropriate member of staff to view a particular child's safeguarding incident. CPOMS is protected through multi-factor authentication. Teachers can view pastoral records and records of communication with parents, again via multi-factor authentication.

Data is transferred to the pupil's new school when they leave at the end of Year 6 (or earlier, if they transfer to another school).
